

**THE REGULAR MEETING OF THE

Provisional minutes pending approval**

June 13, 2017

The regular meeting of the Sherwood Improvement District was held on Tuesday, June 13, 2017, at 6910 SW Fountaintdale Road, Topeka, Kansas. Board members present were George Schuler and Rick Nesbitt.
