

**THE REGULAR MEETING OF THE  
SHERWOOD IMPROVEMENT DISTRICT  
Provisional minutes pending approval**

**August 8, 2017**

The regular meeting of the Sherwood Improvement District was held on Tuesday, August 8, 2017, at 6910 SW Fountaindale Road, Topeka, Kansas. Board members present were George Schuler, Bob Gast and Rick Nesbitt.

Also present were Kevin Holland (CFS Engineers), Lt. Tony DeJesus (Reserves Division of Shawnee County Sheriffs Office), Gene Howerter (3100 SW Lagito Dr.), Tom Thomas (3000 SW Lagito) and Cathy Mosimann.

George Schuler called the meeting to order and welcomed those in attendance.

Lt. DeJesus presented the patrol report as follows:

- Patrol is going out at night more often
- Tutbury is being monitored
- Board discussed with Lt. DeJesus that they are receiving calls on car break-ins and they want to know what can be done about them
  - Board asked him to take this concern and frustration back to the Sheriff and he's got an invitation to please attend a board meeting

Mr. Howerter and Mr. Thomas attended the meeting to discuss with the board the water issue and erosion that continues. There is concern over trash in the lake, pack rats, etc. Kevin Holland will take a look at the area in question. The board also discussed with them the procedure to follow for unmowed grass. They noted there is no speed limit sign on Lagito directly off of 29<sup>th</sup>. Kevin will look into that.

Bob Gast moved to approve the regular meeting minutes for the month of July 2017. The motion was seconded and approved.
